SESSION CONTENT

June 5th, 2025

A PDPM Refresher - Component Review

CMS rolled out this new payment model to SNFs on October 1st, 2019. Since then, the industry has experienced a significant number of changes. This session will review each case-mix component of the Patient-Driven Payment Model.

Five-Star: Meet the New QMs

In January 2025, CMS released the Five-Star ratings utilizing the revised Quality Measures that had been frozen since April 2024. This session will provide a thorough review of each of the new Quality Measures and tips for addressing each measure.

What can your QIO do for you?

During this session, you will hear from a consultant from the Quality Improvement Organization and learn about the education and support you can request from your QIO to improve quality outcomes within your center.

VBP/QRP – What's the Difference?

Are you often lost in the alphabet of acronyms utilized in the MDS world? During this session, you will learn a high-level overview of the SNF Value-Based Purchasing Program (VBP) and the SNF Quality Reporting Program, the difference between the programs, and the impact each has on your center.

Looking Ahead: What's Next from CMS on 10/1/2025

As those in the industry have seen for some time, CMS will be releasing updates and revisions to the MDS that will be effective on 10/1/2025. New Social Determinants of Health, a new section on the MDS? During this session, you will learn about the upcoming changes and revisions and what other changes may be coming.

PA Nursing PDPM Components

CMS announced that states utilizing a RUG-based system for Medicaid reimbursement would need to determine a new payment model, as RUGs would no longer be supported beginning 10/1/2025. Pennsylvania is within a few months of this change. This session will provide a deep dive into the Nursing PDPM component, which will be utilized for Pennsylvania Case Mix, as well as best practices for supportive documentation.

Success under PDPM – The importance of the Relationship between the DON and MDS

The MDS department often reviews chart documentation the most in an SNF. What that department sees or does not see can be valuable information for the DON. In this session, we will discuss the importance of the relationship and partnership between the DON and MDS and how critical that partnership will be to the success of PDPM for the Case mix.

A Review of Managed Medicaid in PA/ CHC Incentive Payments

Are you confused by the Managed Medicaid system? Do you know how to handle a new admission under a Managed Medicaid payment model where the resident receives Medicaid benefits in the community? In this session, we will learn about the managed Medicaid model in PA, how to manage admission, and CHC Incentive Payment Programs.

Updated from the OLTL – PA Case Mix goes PDPM.

As we rapidly approach this transition in Pennsylvania, we have asked the Pennsylvania State Field Operations Supervisor to provide more information on this massive state change and how we can begin to prepare.
